

 - a. Early 1981 singleton should be an open circle.
 - b. Beginning of 1991. The open upside down triangle at the beginning of 1991 should not be there.
 - c. Beginning of 1991. The solid circle under the open upside down triangle should be a solid square
 - d. Beginning of 1992. Open circle should not be there. Should be a solid circle as well as an open upside down triangle.


- e. Early-mid 1995. The open circle at \$48 is currently an open circle over a solid upside down triangle. This needs to be reversed it should be a solid upside down triangle over an open circle.
- 50. Page 236, fn 44. Change "surpassing the criminal liability threshold" to "surpassing a potential criminal liability threshold of 90%."
- 51. Page 238. Price announcement graph for Calpan (B5) SD feed grade (see correct figure on page 3 below)
 - a. The 1983 announcement should be an open circle, not an open diamond.
 - b. The mid/late 1990 and early 1991 announcement should be solid squares, not solid circles.
 - c. The joint announcement in mid-1992 should be a solid square, not a solid circle.
 - d. The singleton in mid-1992 should be an open circle not an open diamond.
 - e. The open circle at the beginning of 1993 should be slightly to the right—it occurred after the open square announcement and before the open triangle announcement. (Open square 1 Mar.; open circle 15 Mar.; open triangle 1 May.)
 - f. The open triangle in early 1994 should move right a bit. The date is 1 Mar. The date for the solid circle is 21 Feb.
 - g. The joint announcement in early 1994 should be a solid circle, not a solid square.
- 52. Page 238. Price announcement graph for Calpan (B5) USP (see correct figure on page 4 below)
 - a. Joint announcement in early 1994 should be a solid circle.
- 53. Page 239. Price announcement graph for E acetate oil USP (see correct figure on page 5 below)
 - a. The lowest singleton announcement in late 1976 should be an open square, not an open circle.
 - b. The asterisk on the "1" below the vertical bar should be removed. The "1" above the bar should be moved directly below the other 1, so that both 1's are below the vertical bar.
 - c. The next four singleton price announcements should be open diamonds, not open circles.
 - d. The late 1985 joint announcement should be a solid circle, not a solid square.
 - e. The mid-1986 joint announcement is correct, but the "2/0" below it under the horizontal axis should be "3/0".
 - f. The late 1990 announcement at approximately \$24 should be a solid circle, not a solid square.
 - g. The two triangle announcements around the start of 1991 should be to the right of the 1991 line with the solid triangle slightly to the left of the open triangle.
- 54. Page 246. 6 lines from the bottom. Change "are quite likely" to "are likely"
- 55. Page 259. 4 lines from bottom. "the changes" should be "changes".
- 56. Back flap of the book jacket. "at Pennsylvania State University" should be "at The Pennsylvania State University"




